



Spend & Save Appliance Promotion

Terms & Conditions

1. Promotion period

The Spend & Save Appliance Promotion ("Promotion") is available for purchases made **from 22 January 2026 until 27 January 2026 at 9:00pm (NZDT), inclusive.**

2. Eligible products

- The Promotion applies only to **selected eligible models** ("Eligible Products").
 - Eligible Products are those **listed on the Spend & Save promotion page on our website at the time of purchase.**
 - Eligible Products may **change during the Promotion period due to stock availability or product changes.**
 - Availability is **while stocks last.**

3. How the discount works

When Eligible Products are purchased **in a single transaction**, customers will receive an **extra discount** applied to the total eligible invoice value as follows:

- **Spend \$1,000 – \$2,999 and receive 4% extra off**
- **Spend \$3,000 – \$4,999 and receive 5% extra off**
- **Spend \$5,000 or more and receive 6% extra off**

The more you spend in one transaction on Eligible Products, the more you save.

4. Pricing basis

- The discount is calculated on the **advertised promotional price of Eligible Products on our website at the time of sale.**
 - Where applicable, Eligible Products may be identified as **market-matched pricing** on the website.
 - The Spend & Save discount applies **after** the advertised promotional or market-matched price is applied.

5. Exclusions

The following are **excluded** from the Promotion and do not count toward the spend threshold:

- Commercial sales
 - Ministry of Social Development (MSD) transactions
 - Gift cards
 - Service-related charges, including but not limited to delivery, installation, removal of old appliances, and packaging removal

6. Online and in-store purchases

- The Promotion applies to purchases made **online or in-store**.
 - For online purchases, the discount will be **automatically applied at checkout** when Eligible Products are added to the cart.
 - For in-store purchases, **sales staff will apply the discount** to the invoice where eligibility criteria are met.

7. GST

All prices, spend thresholds, and discounts are **inclusive of GST**.

8. Returns and refunds

- If one or more products from a Spend & Save transaction are returned and the **original spend threshold is no longer met**, the Spend & Save discount will be **deducted from the refund amount**.
 - If products are returned and the **spend threshold changes**, the applicable discount will be **recalculated and adjusted accordingly**.

9. Combination with other offers

Unless expressly stated otherwise, the Promotion **cannot be used in conjunction with any other offer, discount, or promotion**, including retrospective price matching.

10. General

- Spend thresholds must be met **in a single transaction**.
- We reserve the right to **amend, suspend, or withdraw the Promotion** if circumstances beyond our reasonable control require it.
- This Promotion is subject to **standard consumer guarantees** under New Zealand law.
